NEARLY ALL OF THESE CHILDREN WERE WITHOUT HEALTH INSURANCE TO AFFORDABLY COVER THESE CRITICAL SERVICES. CHILDREN FIRST SUCCESSFULLY CLOSED THIS IMPORTANT HEALTHCARE GAP FOR 700 CHILDREN ENROLLING THEM IN PUBLIC HEALTH INSURANCE AND/OR NAVIGATING HURDLES TO ACCESSING CARE OR COVERAGE.

CHILDREN FIRST ALSO RELEASED WIDELY HAILED PROPOSALS FOR ESTABLISHING NEW ACCOUNTABILITY SYSTEMS FOR IMPROVING EQUITY IN PUBLIC SCHOOLS SO THAT STUDENTS OF COLOR ARE ASSURED THE RESOURCES AND OPPORTUNITIES THEY NEED TO SUCCEED.
