### **Position Summary**

We are seeking an outgoing and highly organized individual to join the K-12 team to engage high school youth enabling them to make the case for improving public education in the Commonwealth of Pennsylvania. The Justice in Education Youth Leadership Coordinator will be supervised by the K-12 Policy Director and work closely with our County Coordinators to grow the base of education stakeholders throughout the region who support our public education funding campaign and educational equity initiatives.

# Key Duties:

- Serve as the primary liaison with organizations that engage youth across the region including school-based and community-based organizations.
- Work with these organizations to identify ways to insert public education advocacy training content into their youth activities.
- Build personal relationships with the youth who want to be highly engaged and support efforts created by the K-12 team that give them pathways to engagement.
- Arrange for Children First and other experts to provide the training at time slots provided by the partner organizations.
- Schedule legislative/community organization meetings for the youth who choose to become advocacy leaders.
- Work with the K-12 team to create presentations/materials for training & related activities.
- Increase visibility of our work by engaging youth on social media that give voice to their experiences and hopes for public education.
- Maintain records with contact information for partner organizations and youth interested in the Justice In Education program.
- Assist in organizing K-12 policy-related events, such as rallies, press conferences, advocacy trainings, forums, report launch events, etc.
