

Snapshot for Montgomery County HIGH-QUALITY, PUBLICLY FUNDED PRE-K

70% of eligible children DO NOT have access

5,750

of the 19,320 children age 3-4 living in this county are eligible

4,042

eligible children DO NOT have access

In this county: 185 pre-k locations are eligible* to participate. Of those, 97 (52%) receive public funds to support high-quality pre-k. 18 (or 56%) of the 32 Pre-K Counts locations are child care.

202 additional pre-k classrooms needed for eligible children

plus 679 more high-quality pre-k classrooms are needed to serve all children age 3-4 in this county.

*Eligible, high-quality providers include Head Start, Keystone STARS 3 and 4 center and group child care, PDE-licensed nursery schools and school districts. Children served data includes those enrolled in high-quality providers using public funds to support their pre-k education.



The Pre-K for PA vision is to ensure that all children can enter school ready to succeed by making high-quality pre-kindergarten accessible to every three- and four-year-old in Pennsylvania.

In Pennsylvania: 3,067 pre-k locations are eligible* to participate. Of those, 2,298 (75%) receive public funds to support high-quality pre-k. 468 (or 46%) of the 1,019 Pre-K Counts locations are child care.

4,364 additional pre-k classrooms
needed for eligible children




Plus, 6,451 more high-quality pre-k classrooms are needed to serve all remaining children age 3-4 in Pennsylvania.

The General Assembly should:

- Support investments of \$30 million in Pre-K Counts and \$3 million in the Head Start Supplemental Assistance Programs to increase the per child rates to address staffing shortages and inflation.
- Ensure the Pennsylvania Department of Education implements the Pre-K Counts rebidding process without service delivery cuts to current service areas, since all Pennsylvania counties have unmet need for publicly-funded pre-k.
