RECOGNIZING THAT PUTTING SMART POLICIES IN PLACE TAKES TIME, CHILDREN FIRST SERVED THE IMMEDIATE NEEDS OF CHILDREN IN SOUTHEASTERN PENNSYLVANIA WHERE THERE ARE QUANTIFIABLE GAPS, SPECIFICALLY IN ACCESS TO VISION AND DENTAL CARE, AS WELL AS ENROLLMENT IN HEALTH INSURANCE.

DURING COVID, OUR HEALTHCARE EXPERTISE WAS INVALUABLE. IN SPITE OF THE MASSIVE SHUTDOWN, MORE THAN 1,000 CHILDREN HAD THEIR EYES EXAMINED AND RECEIVED, IF NEEDED, TWO FREE PAIRS OF GLASSES. ADDITIONALLY, NEARLY 500 CHILDREN HAD MUCH NEEDED FREE, IN-PERSON DENTAL SCREENING EXAMS WITH FOLLOW-UP VISITS FOR THE MORE SERIOUS CASES. NEARLY ALL OF THESE CHILDREN WERE WITHOUT HEALTH INSURANCE TO AFFORDABLY COVER THESE CRITICAL SERVICES. CHILDREN FIRST SUCCESSFULLY CLOSED THIS IMPORTANT HEALTHCARE GAP FOR 700 CHILDREN ENROLLING THEM IN PUBLIC HEALTH INSURANCE AND/OR NAVIGATING HURDLES TO ACCESSING CARE OR COVERAGE.

CHILDREN FIRST ALSO RELEASED WIDELY HAILED PROPOSALS FOR ESTABLISHING NEW ACCOUNTABILITY SYSTEMS FOR IMPROVING EQUITY IN PUBLIC SCHOOLS SO THAT STUDENTS OF COLOR ARE ASSURED THE RESOURCES AND OPPORTUNITIES THEY NEED TO SUCCEED.
